Section 6 of the form relates to Personal Interests.

Note:

- 1. Where you consider that information relating to any of your interests is a 'Sensitive tnterest' you need not include that interest provided you have consulted with the Monitori"^9 Officer and they agree that it need not be included. A 'Sensitive Interest'is an interest which com/d create or is likely to create a serious risk that you or a person connected with you may be subjected to violence or intimidation.
- 2. Where the interest is no longer a 'Sensitive Interest' you must notify the Monitoring OffiCer within 28 days of thot change.
- J. This form gives general guidance, but is not comprehensive. The Somerset Council's Code of Conduct gives precise reguirements. The localism Act and the Regulations named above should be referred to where necessary. Continuation sheets should be used where needed and clearly marked.



 - (3) fail to give further notices in order to:
 - bring up to date information given in this notice; and

• declare an interest that I acquire after the date of this notice and have to declare.

and that any breach of the Code of Conduct can be referred to the Standards Committee.

15.3 I understand that failure (without reasonable excuse) to register or disclose any Uisclosab/e Pecuniary *tn*(*erest in* accordance with section 30(1) or 31{2), (3) or (7) of the Localism Att 2011, or participating in any discussion or vote in contravention of section 31(4) of the Localism Act 2011, or taking any steps in contravention of section 31(8) of the Localism Act 2011 is a criminal offence and risks a fine not exceeding level 5 on the standard scale (currently E5,000) or disqualification as a member for a period not exceeding 5 years.
